- DoE Tasmania
- And provisionally endorsed by AEU Tas.

Due to work that Sandra Lewis and I have been doing on contextualising units in the Cert IV Laboratory Techniques and the Diploma of laboratory Technology, IBSA (Innovation & Business Skills Australia) now knows that SETA exists and will hopefully continue to include science technicians when considering changes to those qualifications.

SETA has been and will continue to advocate our position as school science laboratory technicians.
